[Enhanced Job Skills Program at Lafayette Parish Correctional Center](#) The Enhanced Job Skills Program, operated by the Lafayette Parish Correctional Center, assists individuals who are incarcerated for drug-related charges in preparing for employment upon release. The four-phase program begins with assessment and career selection, progressing to computer-based skills program that teaches basic skills for over 200 types of job categories. Phase III involves job searching and interview techniques. Phase IV begins two months prior to release with assistance in job placement. The agency maintains contact with participants for six months following release.
